AN ORDINANCE AMENDING ORDINANCE 2021-31 ADOPTED MAY 3, 2021 BY ESTABLISHING COMPENSATION OF CERTAIN AUTHORIZED POSITIONS WITHIN THE VERMILION DEPARTMENT OF PARKS AND RECREATION AS HAVE BEEN FAVORABLY RECOMMENDED BY THE CITY’S PARKS AND RECREATION BOARD AND DECLARING AN EMERGENCY.

WHEREAS, the Vermilion Parks and Recreation Board at their meeting of May 18, 2021 favorably recommended to the Vermilion City Council to amend the various pay rates for the Vermilion Community Pool employees.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Vermilion, Counties of Erie and Lorain, State of Ohio:

SECTION 1: That the Service Director upon the recommendation of the Vermilion Parks and Recreation Board and Parks Operation Manager is hereby authorized to employ a Pool Manager at a rate of \$15.00 per hour and a Pool Assistant Manager at a rate of \$13.00 per hour.

SECTION 2: That the Service Director upon the recommendation of the Vermilion Parks and Recreation Board and the Parks Operation Director is hereby authorized to employ up to ten (10) Lifeguards and they shall be paid at a rate of \$12.00 per hour.

SECTION 3: Any recreation activity sponsored by the Vermilion Parks and Recreation Department and approved by motion of the Board, shall be funded as follows:

All revenue raised for the Vermilion Community Pool will first be submitted to the Department of Finance for collection. All expenses and salaries will be paid from the revenue raised from the Vermilion Community Pool after authorization of the Chairperson of the Recreation Board.

SECTION 4: That all appointments referred to herein shall be considered seasonal part-time personnel of the City of Vermilion and shall be within the non-classified, non-competitive service and shall receive no fringe benefits.

SECTION 5: This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 6: That this Ordinance is declared to be an emergency for the public peace, health, and safety of the City; and for the emergency necessity being the City needs to employ individuals before the pool opening, wherefore, this Ordinance shall take effect immediately upon its passage and approval of the Mayor, providing it meets the statutory requirements for passage; otherwise, it shall take effect and be enforced from and after the earliest period allowed by law.
