S. Herron MOVED; F. Loucka seconded to place Ordinance 2019-31 as amended on the October 28, 2019 agenda for a third reading. Roll Call Vote 6 YEAS; 1 ABSTENTION (Gabriel). MOTION CARRIED.

First Reading - Ordinance 2019-59: AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF VERMILION, OHIO TO ENTER INTO A CONTRACT WITH BAIN ENTERPRISES OF STOW, OHIO FOR THE WACHS WATER VALVE EXERCISING AND MAINTENANCE TRAILER; AUTHORIZING THE FINANCE DIRECTOR TO MAKE PAYMENT TO SAID AWARDEE IN AN AMOUNT NOT TO EXCEED SIXTY-NINE THOUSAND NINE HUNDRED NINETY-FIVE DOLLARS (\$69,995.00) AND DECLARING AN EMERGENCY.

Valerius said it's both and mentioned the city received \$40,000 in a grant from the Ohio Bureau of Worker's Compensation and they are sending the city a check for this amount. Therefore, the city's portion will be \$29,995. Roll Call Vote 7 YEAS. <u>MOTION CARRIED</u>.
